Terms & Conditions

1. This promotion called “**March Madness Giveaways**” and will be referred to as “The Promotion” is organized by Asia Capital Markets LLC (ACMarkets, we, us, our, the Promotor) (RCN: 316 LLC 2020, AFSL: 3426359); and is open to ACMarkets customers based in all jurisdictions.

2. These Terms and Conditions constitute our “Offer” to you (the client, you, your, the Participant).

3. By opening a new ACMarkets account under this Promotion, the Client acknowledges they have received, read, and agree to be bound by these Terms and Conditions.

4. These Terms and Conditions together with our Client Agreement and PDS form the Agreement. To the extent of any inconsistency, the PDS and Customer Agreement Prevails.

5. This Promotion is available to qualifying accounts, referred to in clause 5, 6, 11 and 12.
